### Goal #1 Goal

**EDIT** 

We want to provide support to our students in Language Arts and Mathematics. We want students to show growth in these critical subjects. In August, we will administer Jordan District pre-tests in Math, Reading and Writing in grades K-6. We will also administer DIBELS beginning-of-year assessments for grades K-3. Then, through our work in Professional Learning Communities, we will provide targeted intervention in each of these subjects. At the end of the 2019-20 school year, we want students to grow an average of 35% or higher on these assessments. We also want to see an increase in on level proficiency and a reduction of below level proficiency in DIBELS.

#### **Academic Areas**

- Reading
- Mathematics
- Writing

#### Measurements

We will administer Jordan District pre and Post asssessments for math, reading, and writing. Since we are a new school, we do not have baseline measurements currently. We can use our pre-assessments in August as baseline measures including DIBELS beginning year assessment. We will administer the post-assessments and DIBELS end of year assessment in May, 2020 to determine effectiveness of our goal.

### **Action Plan Steps**

- 1. Administer the JSD pre-assessments and DIBELS beginning year assessment in August, 2019 for math, reading, and writing.
- 2. Meet in PLCs to analyze the data. 3. Provide targeted interventions based on data in math, reading and writing.
- 4. Provide ongoing support using Reading Club pull out with paraprofessional support, enrichment for students showing mastery with paraprofessional support, and teacher support during rotations with paraprofessionals providing rotation coverage including using chromebooks for the computer lab and enrichment program.
- 5. Progress monitor using three JSD Benchmarks in math, reading and writing. Also, use DIBELS Mid-year results to monitor growth in reading.
- 6. Administer post tests in math, reading, and writing. Administer DIBELS end of year test to see final growth results.
- 7. Analyze results to see if we were able to achieve our goals.
