- 2. Vote on Chair -Megan Dixon
- 3. Review 2021-22 Land Trust Plan SCC discussed the goal of monitoring Acadience and growth measures throughout the school year. Land Trust funds are being utilized to support rotation assistants in the building to promote teacher PLC time to determine instruction needs for students. Teachers will provide support and direction to funded literacy/math assistants to provide strategic and specific instruction. In addition, Land Trust funds are being utilize to support productive play out at recess and conflict resolution strategies students and staff utilize.
- Review Digital Citizenship Plan In the past we have used Common Sense Media to support digital citizenship. PTA has purchased an Internet Detective curriculum to promote internet safety and will

promote the curriculum during White Ribbon Week in February.

- 5. Review Bus Permits/Approve or Deny Bus Permits We discussed safety reasons that warrant students being given priority to ride a school bus. Students in the Regent Gardens area and are East of Porter Rockwell have a significant safety concern with walking safely to school. The SCC determined that students in this area be given first priority with bus permits. After students in this area have been accommodated, the SCC determined that students who live farthest from the school be awarded a bus permit.
